A Local Law to Amend the Richmond Town Code at Part II, “General Legislation,” Chapter 178 “Taxation” to Amend “Article V. Tax Levy Limit Override”, a Provision Authorizing The Override Of The 2021 Tax Levy Limit.

as follows:

Section 1: Authorization

The adoption of this Local Law is in accordance with Section 10 of the New York Municipal Home Rule Law and subdivision 5 of General Municipal Law §3-c, which expressly authorizes the Town Board to override the tax levy limit by the adoption of a local law approved by vote of at least sixty percent (60%) of the Town Board.

Section 2: Title and Purpose

This law shall be known as and may be cited as Local Law No. _____-2020, to amend the Richmond Town Code at Part II, “General Legislation,” Chapter 178 “Taxation” to amend “V. Tax Levy Limit Override”, a provision authorizing the override of the 2021 tax levy limit.

Section 3: Legislative Finding

The Town Board of the Town of Richmond finds and hereby determines that the costs to provide Town services and to fund Town operations will continue to increase for 2021 and it is necessary

to amend the Richmond Town Code to override the tax levy limit to enable the Town to continue to provide necessary services.

Section 4: Amendment.

Part II of the Richmond Town Code, “General Legislation”, Chapter 178 “Taxation” shall amend “Article V- Tax Levy Limit Override” as follows:

Article V. Tax Levy Limit Override.

§178-11 - 2021 Tax Levy Limit Override

The Town is authorized to override the 2021 tax levy limit and adopt a budget for the fiscal year beginning January 1, 2021 and ending December 31, 2021 that requires a real property tax levy in excess of the tax levy limit defined by General Municipal Law 3-c.

Section 5: Validity and Severability

Should any word, section, clause, paragraph, sentence, part or provision of this local law be declared invalid by a Court of competent jurisdiction, such determination shall not affect the validity of any other part hereof.

Section 6: Repeal, Amendment and Supersession of Other Laws

All other ordinances or local laws of the Town of Richmond which are in conflict with the provisions of this local law are hereby superseded or repealed to the extent necessary to give this local law force and effect during its effective period.

Section 7: Effective Date

This Local Law will take effect upon filing in the office of the New York State Secretary of State.

Section 8: Effective Date

This local law shall take effect immediately upon filing with the Secretary of State.

5. (City local law concerning Charter revision proposed by petition.)
